UWL Full-Time Undergraduate Bursary Scheme 2020/21Information

The University will be allocating up to 400 bursaries in total in 2020/21. All applicants meeting the eligibility criteria will be awarded the bursary until the full limit of awards has been reached.

BURSARY INFORMATION

The bursary is provided to support students with living costs during their studies. Successful applicants will receive £500 in each eligible year of study, paid in three instalments each year subject to maintaining satisfactory engagement, submission to assessment and progression to the next level of study. Students may receive up to £1,500 in total from this bursary, based on receiving it for a maximum of three years. Students who apply for the bursary in the second or third year of their course will not be eligible to receive payments for any years prior to the year in which they apply (e.g. if you apply in the second year of your course you will only receive payments in your second and third years, up to a total of £1,000). Successful applicants will not need to reapply in subsequent years.

The bursary is paid into your nominated bank account. Successful applicants will be contacted with details on how to provide their bank details to the University for payment. Please do not provide any bank details at this stage.

Students will not receive the yearly allowance if:

- They are on a repeat year
- They are on a placement or sandwich year

ELIGIBILITY

Students must fulfil all criteria below:

- be paying **Home** or **EU** fees
- be from a household with a gross income of less than £25,000 per annum.

Applicants must either have applied for means tested student support from the Student Loans Company (SLC) and given consent to share information in order that their declared household income can be verified **or** must provide supporting evidence of household income with their application (see 'How to Apply')

 be studying on a full-time undergraduate bachelor's degree taught at UWL (including Drama Studio London and ScreenSpace)

If the number of applications received is over 400, priority will be given to:

- Care leavers
- Estranged students
- Disabled students
- Early applicants
- Level 4 students

The following students are **not** eligible:

- Students on a BA/BSc/BEng with Foundation Year;
 Home/EU students on these courses will automatically
 be eligible for the Path to Success Scholarship for which
 no application is necessary
- Students on courses eligible to apply for additional funding from the NHS Learning Support Fund (e.g. Nursing and Midwifery courses)
- International (non-EU) students
- Students whose fees are paid or part-paid through a sponsorship arrangement (e.g. degree apprentices or students studying on a collaborative programme)
- Students studying at affiliate or partner institutions

Notifications of award will be conditional on confirmation that applicants have met the conditions of their offer, have fully enrolled at UWL, and the provision of any evidence required as stated opposite.

HOW TO APPLY

Applicants must complete all sections of this form.

If you have applied for a means tested maintenance loan from the Student Loans Company and given consent to share your information with the University, we will use the SLC assessment of your household income. If you have applied for a maintenance loan but we are unable to assess your household income through SLC, we will contact you to provide additional supporting evidence.

If you have not applied for a means tested maintenance loan, if your application is still in progress following enrolment, or if you are an EU student not eligible to receive a maintenance loan, you must submit evidence of your total household income for either:

- Your parent(s) if you are under the age of 25
- You and your partner/spouse (if applicable) if you are over 25 and/or an independent student

Please provide evidence from **one** of the following options:

- P60(s) or equivalent annual tax statement(s) for the most recent tax year
- Most recent self-assessment tax return(s) if selfemployed
- 3 months' worth of recent wage slips
- A full recent UK benefit entitlement letter or statement showing your household income used in the calculation

Evidence can be provided as a scan or photograph. Please ensure all evidence is clear and legible.

Where evidence is not in English, students must provide a certified translation of documents evidencing their household income in their home country.
